- **Online Registration** – Roger reminded the board that all online registration payments will be charged an additional \$5.00 per transaction. In-person registration events are currently being planned for the month of May.
- **In-Person Registration Events** – Mike included the in-person registration events in the recent email that went to the DASL Team Managers. Denver Sweet will host the events due to the restrictions under their 5 Star Program that Mary's has with the CDPHE. Roger stated that the R&R will host an in-person registration event on May 22, 2021 from 1:00pm – 3:00 pm. Mike stated that Denver Sweet has donated \$1.00 drink/appetizer cards for players attending the in-person registration events. The special will run until May 23, 2021. PC asked about the capacity restrictions at the R&R. Roger stated that registration will be held outside of the R&R.
- **Manager's Meeting** – May 15, 2021 from 5:30 pm – 6:30 pm with the location TBD as of to date Mike is waiting to hear back from Mary's to host the event.
- **Special Committee Updates** – Committee updates were then given by each committee chair.
 - **Social Committee & Membership** – Thomas Pugh asked if DASL would have a field day for 2021. Roger suggested to have a field day on April 25, 2021. PC will work with Denver Parks & Recreation to obtain a permit for field day.
 - **Fundraising Committee** – Mike secured all the fundraising events at Denver Sweet that will follow in-person player registration during the month of May. Kat asked if reminders could be sent out to team managers. Mike will follow up with the managers to remind them of the in-person events. Mike discussed the 25th anniversary t-shirts that will be sold during the DASL May events. Shirts have been ordered and will be ready for the first in-person registration event. Each shirt will retail at \$25.00. Roger stated that he is scheduling meetings to meet with potential league sponsors.
 - **Rocky Mountain Roundup Tournament Committee** – Mike updated the board on the progress that is being made to plan the 2021 Rocky Mountain Roundup. Hotels have been secured, and the tournament committee recently met to discuss the protest rules and rules of play at the recent committee meeting. Once the rules have been retyped, they will be posted to the Rocky Mountain Roundup website. Mike also updated the board that the team registration fee has been established at \$335 per team.
 - **Ratings Committee** – Roger stated that he is currently looking into a Ratings Clinic to be held on June 5, 2021 for team managers. PC
